Warthog Lacrosse Parent Waiver & Release of Liability

As the parent or legal guardian of a participant in Warthog Lacrosse, I understand and accept the following terms as a condition of my child's involvement in practices, games, and events organized by Warthog Lacrosse ("WL"):

1. Acknowledgment of Risk

I recognize that participation in lacrosse involves physical activity that carries inherent risks, including but not limited to injury, disability, or death. I understand that while WL coaches and staff prioritize safety, these risks cannot be entirely eliminated.

2. Assumption of Responsibility

I voluntarily assume all risks associated with my child's participation, including those arising from the negligence of WL staff, volunteers, other participants, or facility conditions. I accept full responsibility for any injury or loss that may occur.

3. Medical Consent

I authorize WL coaches, staff, or designated personnel to seek emergency medical treatment for my child if necessary. I understand that WL does not provide medical insurance and that any medical expenses incurred will be my responsibility.

4. Code of Conduct Agreement

I pledge to uphold a respectful, supportive environment at all WL events. I will:

- Refrain from coaching my child or other players during games or practices unless I am an official team coach.
- Avoid the use of drugs, tobacco, or alcohol at WL events.
- Support coaches, officials, and players with positive encouragement and sportsmanship.

5. Media Release

I grant WL permission to use photographs or video of my child taken during WL activities for promotional or educational purposes, without compensation.

6. Release of Liability

I, for myself and on behalf of my heirs, assigns, and next of kin, hereby release and hold harmless Warthog Lacrosse, its coaches, staff, volunteers, sponsors, and facility owners from any and all liability for injury, loss, or damage to person or property, to the fullest extent permitted by law.
